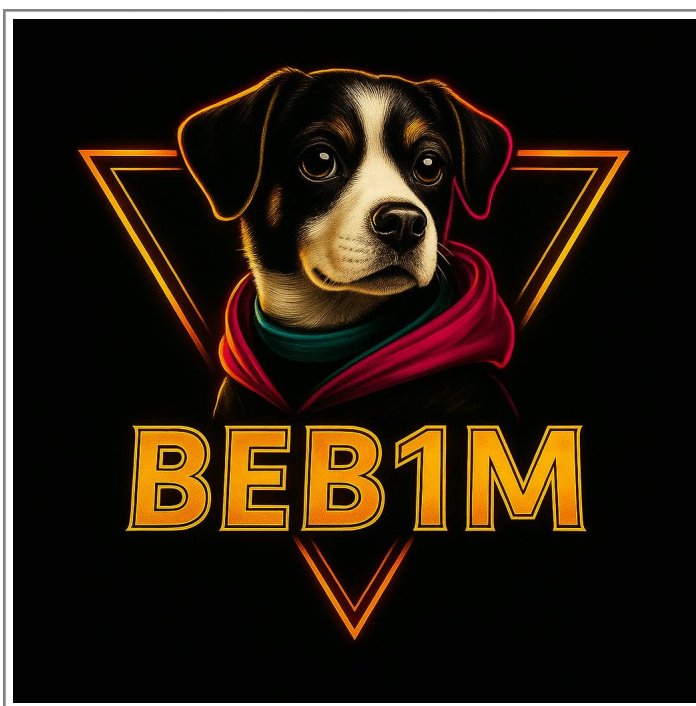

3. BEB1M TOKEN UTILITY

BEB1M is not a speculative meme; it is the primary payment layer across the entire BeB Crypto ecosystem.

Businesses tokenized through BeB Crypto receive discounts when using BEB1M.

Registration fees, voting, athlete sponsorship tiers.

5. LOCKING MILESTONES (UP TO \$100M MARKET CAP)

To stabilize market psychology and ensure long-term trust, BEB1M implements a unique milestone-based locking framework:

Milestone	Action
\$1M MC	2% additional locked for 6 months
\$5M MC	3% additional locked for 6 months
\$10M MC	5% additional locked for 6 months
\$20M MC	8% additional locked for 6 months
\$50M MC	10% additional locked for 6 months
\$100M MC	12% additional locked for 6 months

Upon reaching a \$100M market capitalization, 50% of the total supply will be locked.

Token Source for Locking

Tokens are locked from:

1. Strategic Reserve, OR
2. If insufficient → tokens are purchased from open market then locked.

All locking actions will be conducted on-chain and can be publicly verified through Solana explorers.
